CLEANSING NOTICE UNDER SECTION 708A(5)(e) OF THE CORPORATIONS ACT

This cleansing notice (**Cleansing Notice**) is given by Intelligent Monitoring Group Limited (ASX: IMB; **IMG** or the **Company**) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).

The Company advises that on 14 November 2024 it issued 41,666,667 ordinary fully paid shares (**Placement Shares**) to various institutional and sophisticated investors at \$0.48 per share under a placement. The Placement Shares were issued pursuant to the Company's existing placement capacity under ASX Listing Rule 7.1.

In addition to the issue of the Placement Shares, the Company is offering new ordinary fully paid shares under a Share Purchase Plan (SPP) at the same issue price as the Placement Shares to eligible existing shareholders of the Company to raise up to approximately \$3 million (SPP Shares). The SPP Shares will be offered in accordance with the ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547 (ASIC Instrument) and pursuant to the terms of a Share Purchase Plan Booklet. The Share Purchase Plan Booklet was despatched to eligible shareholders of the Company on 15 November 2024.

The opening of the SPP has been deferred until 10:00 am (AEDT) on Tuesday, 19 November 2024.

IMG gives notice under section 708A(5)(e) of the Corporations Act 2001 that:

(a) the Placement Shares have been issued without disclosure to investors under Part 6D.2 of the Corporations Act;
